

## Recombinant Human Endocrine Gland-derived Vascular Endothelial Growth Factor

<b>M.Wt</b>	Approximately 9.7 kDa, a single non-glycosylated polypeptide chain containing 86 amino acids.

<b>Appearance</b>	Sterile Filtered White lyophilized (freeze-dried) powder.
<b>Stability &amp; Storage</b>	Use a manual defrost freezer and avoid repeated freeze-thaw cycles - 12 months from date of receipt, -20 to -70 °C as supplied - 1 month, 2 to 8 °C under sterile conditions after reconstitution - 3 months, -20 to -70 °C under sterile conditions after reconstitution
<b>Formulation</b>	Lyophilized from a 0.2 µm filtered concentrated solution in PBS, pH 7.4, 0.02 % Tween-20.
<b>Reconstitution</b>	We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile distilled water or aqueous buffer containing 0.1 % BSA to a concentration of 0.1-1.0 mg/mL. Stock solutions should be apportioned into working aliquots and stored at ≤ -20 °C. Further dilutions should be made in appropriate buffered solutions.
<b>Biological Activity</b>	Fully biologically active when compared to standard. The ED as determined by a cell proliferation assay using bovine EJC cells is less than 2.0 µg/ml, corresponding to a specific activity of > 500 IU/mg.
<b>Shipping Condition</b>	Gel pack.
<b>Handling</b>	Centrifuge the vial prior to opening.
<b>Usage</b>	For Research Use Only! Not to be used in humans.

Purity	> 98 % by SDS-PAGE and HPLC analyses.
Endotoxin	Less than 0.1 EU/μg of rHuEG-VEGF as determined by LAL method.
